WHEREAS, undersigned has presented to the City, a Plat of the division of lands known as \_\_\_\_\_\_\_ as shown on said Plat; that the construction of said improvements shall be made in accordance with the plans, specifications and estimates to be approved by the City Engineer, under his supervision and satisfaction; that all expense of the construction of said improvements, of whatever kind and nature, shall be borne by the undersigned so platting and dedicating said land; that the undersigned shall indemnify and save harmless the City, from any and all injury and damages which it may suffer or be subjected to by reason of the construction of said improvements or by taking over and acceptance of the said improvements in the dedication of said Plat, until said improvements have been completed and have been accepted by the City.

said Escrow Agent in the following manner to wit:

- To the undersigned, periodic payments of the contract costs of improvements after the Escrow Agent has received written approval from the City that said improvements have been completed and are approved by the City Engineer.
- To the City, an amount, estimated to be \$\_\_\_\_\_.00 as reimbursement to the City for the Costs of the City Engineer and City Law Director as required by Waterville Municipal Code §1117.02.
- 3) To the undersigned, the balance, if any, in said escrow account when the Escrow Agent has been directed, in writing, to disburse said balance by the City and that all improvements have been completed and approved by the City Engineer and all improvements have been accepted by the City.
- 4) In the event undersigned fails to perform any or all of the conditions or obligations herein required of it to be performed or fails to comply fully with any applicable provisions of the Ohio Revised Code or the Waterville Municipal Code, as determined by the City Engineer, exclusively, then said Escrow Agent is authorized and directed to disburse any balance in said escrow account to the City, under the written demand of the City Engineer, and said City shall have the right, at its exclusive option, to complete the installation of said improvements together with all costs and expenses in connection herewith, including the fee of said Escrow Agent shall be paid by the undersigned.

**NOW, THEREFORE,** if the undersigned shall honestly and faithfully perform all the conditions herein required by it to be performed, then this obligation shall be null and void, otherwise to remain in full force and effect.
