Mayor Pedro

NEW BUSINESS:

A. RESOLUTION 24-24 A RESOLUTION REPEALING RESOLUTION 72-06 AND APPOINTING KATI THARP DOWNEY AS LAW DIRECTOR FOR THE CITY OF WATERVILLE

With the recent retirement of former Law Director Phillip Dombey, the City Charter requires the appointment of a Law Director by City Council. It is the recommendation of Mr. Dombey and the Municipal Administrator that current Assistant Law Director Kati Tharp be appointed as Law Director of the City of Waterville.

Mr. Borowski moved to adopt Resolution 24-24, Mr. Garver seconded the motion, which passed by a unanimous voice vote.

B. RESOLUTION 25-24 A RESOLUTION AUTHORIZING THE TRANSFER OF CASH FUNDS FROM THE GENERAL FUND (100) TO THE PARKS AND GREEN SPACE FUND (225)

This Resolution authorizes the transfer of \$75,000 from the General Fund (100) to the Parks and Green Space Fund (225) to maintain a sufficient fund balance in the Parks and Green Space Fund. Although the City does not maintain a large balance in this fund, the current fund balance is approximately \$11,000. The City is also expecting to receive a grant reimbursement of approximately \$50,000 which will be deposited into this fund by the end of the year.

Mr. Wagner moved to adopt Resolution 25-24, Mr. Rozic seconded the motion, which passed by a unanimous voice vote.

C. ORDINANCE 07-24 AN ORDINANCE AMENDING ORDINANCE 06-24, THE AMENDED FY 2024 ANNUAL APPROPRIATION ORDINANCE AND DECLARING AN EMERGENCY

This Ordinance would authorize the second amendment to the 2024 Appropriations. Significant items included in this amendment are: revenue and expense for the transfer from the General Fund to the Parks and Green Space Fund (\$75,000); increased investment income revenue (\$176,318); Ohio Net Profit Income Tax revenue (\$50,000); EMS charges for service revenue (\$94,000) and additional expense for additional paving and engineering costs (\$65,000); for ongoing legal litigation (\$25,000); for health insurance (\$25,700); for sewer department contract services (\$22,000); for additional fire vehicle maintenance (\$15,000) and other routine items. Detailed information on this amendment is enclosed with this ordinance.

Mayor Pedro made a motion to suspend the rules to allow for the passage of Ordinance 07-24 as an emergency measure. Mr. Borowski seconded the motion.

Roll Call: Mayor Pedro - yes, Mr. Borowski - yes, Mr. Garver - yes, Mr. Wagner - yes, Mr. Rozic - yes and Mr. Bruno - yes. The motion passed unanimously.

Mayor Pedro made a motion to move for the passage of Ordinance 07-24 as an emergency measure. Mr. Garver seconded the motion.

Roll Call: Mr. Wagner – yes, Mr. Garver – yes, Mr. Borowski – yes, Mr. Bruno – yes, Mr. Rozic - yes and Mayor Pedro – yes. The motion passed unanimously.

D. RESOLUTION 26-24 A RESOLUTION AUTHORIZING THE MUNICIPAL ADMINISTRATOR TO AWARD A CONTRACT TO EBONY CONSTRUCTION COMPANY, INC. FOR THE FARNSWORTH ROAD WATERLINE AND PAVING IMPROVEMENT PROJECT

This Resolution authorizes a contract with Ebony Construction, Inc. of Sylvania, Ohio for the Farnsworth Road Waterline and Paving Improvement Project at a cost of \$632,975.65. Bids were opened on July 17, 2024 and the City received three competitive bids for this project with the low bid submitted by Ebony Construction Company. The project will replace approximately 1,226 feet of 6-inch waterline with new 8-inch waterline, 3 fire hydrants and 7 service connections. Farnsworth Road will be repaved from the Anthony Wayne Trail to River Road along with a portion of River Road between Mechanic and Farnsworth Roads in front of Parker Square. It is the recommendation of the City Engineer and administrative staff to award the contract for the Farnsworth Road Waterline and Paving Improvement Project to Ebony Construction Company, Inc. In business since 1986, Ebony Construction has successfully completed projects in the City in the past. The engineer's recommendation letter is included with a copy of this legislation.

Mr. Wagner moved to adopt Resolution 26-24, Mr. Rozic seconded the motion, which passed by a unanimous voice vote.
