A. RESOLUTION 01-25 A RESOLUTION DECLARING THE INTENT AND AUTHORIZING THE SALE OF MUNICIPALLY OWNED PERSONAL PROPERTY, INCLUDING MOTOR VEHICLES, ROAD MACHINERY, EQUIPMENT, TOOLS OR SUPPLIES, WHICH IS NOT NEEDED FOR PUBLIC USE, OR IS OBSOLETE OR UNFIT FOR THE USE WHICH IT WAS ACQUIRED, DURING THE CALENDAR YEAR 2025 BY INTERNET AUCTION, PURSUANT TO OHIO REVISED CODE SECTION 721.15(D)

The Ohio Revised Code, specifically Section 721.15(D), requires a yearly resolution of intent to sell municipally owned personal property when sold by internet auction. In November 2008, Council approved Resolution 54-08 authorizing a contract with GovDeals, Inc. to conduct internet auctions to sell municipally owned personal property on behalf of the City. This Resolution also includes a second internet auction service called Municibid.Com, LLC as a provider of this service. Due to the yearly requirement, this Resolution is one of our annual legislative "housekeeping" items.

B. RESOLUTION 02-25 A RESOLUTION OF THE CITY OF WATERVILLE, LUCAS COUNTY, OHIO SUPPORTING THE OHIO COMMISSION FOR THE UNITED STATES SEMIQUINCENTENNIAL (AMERICA 250-OH)

This Resolution affirms the support of the City of Waterville for the State of Ohio's "Commission for the United States Semiquincentennial (AMERICA 250-OH)" which seeks to organize and support local communities in preparation for the celebration of the 250th anniversary of the independence of the United States in 2026. By passing this Resolution, the City and local community groups could be eligible for up to \$5,000 in financial assistance to plan for community events in 2026.

Mr. Garver moved to adopt Resolution 02-25. Mr. Wagner seconded the motion, which passed by unanimous voice vote.
